I have asked for your support over the past 13 years, and you have given me your support. I am asking for your support one more time as I run for the high office Supreme Junior Vice Commander.






Honor Degree




The exception is those Grands having Conventions less than 30 days before Supreme; then warrants are sent in immediately. **Treasurers: It is your responsibility to ensure that anyone running for an office is current on their membership dues at the time of nomination.** Make sure all information is correct on those Installation Reports (because this is where the Supreme Secre-



tary/Treasurer gets information for the Roster). Do not wait on sending these in.

As most of you know, we have a new Supreme Treasurer. She is doing an awesome job on updating information into the database. Get those Membership Transmittals to her now. **I have extended the membership cutoff date until 31 January. Do not sit on those transmittals.**

Remember that all Treasurers must have time to process them. A reminder to all, if your 2024 dues are not paid by 31 January on 1 February you will become a **“Member not in good standing.”**

I personally want to thank all of you for your hard work and support that you have given to me. We still have a few months to go. I hope to see you as I travel throughout the country visiting the Grands.



Auxiliary Members,

Here it is a New Year. What does the month of January symbolize?



January was named for the Roman god Janus, known as the protector of gates and doorways, who symbolize beginnings and endings. Janus is depicted with two faces, one looking into the past, the other with the ability to see into the future. So, we need to look towards the future.

The last few months have been hectic and exciting. We have had Tomb Trek and Cootie Christmas. What an honor and privilege it was to attend these events. I have visited a few of the Auxiliaries that are not in a Grand. By this time all but a couple of Auxiliaries not in a Grand have been inspected. Here are some reminders:

1. **MEMBERSHIP**: On 1 Feb 2024, (this year only) any member not currently holding a 2024 membership dues card is NOT a member in good standing. **Normally, the dues are to be paid by 31 December. I have extended that to 31 January.** They cannot attend meetings nor claim hospital hours and are ineligible to be elected or hold an office. Dues must be paid by 1 Sep 2024, or these individuals will have to rejoin as a new member. Payment of their dues will restore all rights immediately. All treasurers, please transmit dues ASAP.

2. **ALL AUXILIARIES**: Not having 10 or more members paid for the current year are no longer in good standing with the Supreme organization. The Auxiliary cannot conduct any business, nor elect and install new officers, until the required number of members has been paid.

3. **GRAND PRESIDENTS**:

- Your VAVS Representatives and Deputies should be performing their duties at the VA Hospitals. It is your responsibility to visit all the VA Hospitals in which you have a VAVS Representative and Deputies. If there is a problem, as Grand President, you should be planning on appointing replacements.

- Your visits to your Auxiliaries within your Grand should be almost complete. Please send your Inspection Reports to Supreme Inspector Marquitta Hill, PO Box 16113, Hattiesburg, MS 39404. E-mail: nicolevfw@yahoo.com

4. **GRAND CONVENTIONS are just around the corner:** I will be assigning a Supreme Representative to attend your Grand Convention. For those who have not already done so, please send your Request for Supreme Representative for your Grand Convention to me now. Every effort will be made to send your choice. But bear in mind that it is not always possible. The Supreme Rep will be reviewing your books. When you are inspected, be sure to have the hard copies of the documents that are required available for the inspectors (copy of the bond (Due in August), audits, ledgers, banks statements, CD statements, EIN#, a copy when the 990 or 990N e-postcard was filed (this should be a receipt from the IRS) and Secretary's minutes. The inspectors will need to sign on each of these documents.

SUPREME REPRESENTATIVES WILL ATTEND ALL FUNCTIONS OF YOUR CONVENTION.

5. **TREASURERS ON ALL LEVELS:** No checks are to be made out to any Supreme or Grand Chairman. Checks are made out to the organization, not an individual. Checks for the any Supreme Program are to be made out to Supreme MOCA & sent to

- All Auxiliaries must have their own EIN to maintain their non-profit status under the umbrella of the Supreme Organization and **it is the responsibility of the Treasurer to file the 990n epostcard annually.** This is your EIN number and cannot be shared. This number is to be provided to the Supreme Quartermaster, 604 Braddock Avenue, Turtle Creek, PA 15145. A reminder: Your EIN is for non-profit status, not tax exemption status. Please review the requirements for a tax exemption number before applying for one.

6. **MOC AUXILIARIES.** **Auxiliaries in a Grand:** Nominations, elections, and installations of officers must be completed between January 15th and March 31st, 2024; **unless** the Supreme President has given the approval in writing, to delay it. IAW MOCA By-Laws Section 305, "Installations shall be held at a date to correspond with the Pup Tent and if desired by mutual consent of the Pup Tent and Auxiliary, may be joint. Sky Pilot / Chaplain of the Year Program 2022-2023


Objective: The Supreme Commander desires that special recognition be given to outstanding Sky Pilots and Chaplains in the Military Order of the Cootie.

The Supreme Sky Pilot or Chaplain of the Year Program is an excellent opportunity to recognize your best Sky Pilot or Chaplain. Sky Pilots of the Pup Tent, Chaplains of the Grand, District or Area, have been recognized at the Supreme Scratch each year as *Supreme Sky Pilot of the Year* or *Chaplain of the Year* since Cootie Year 1975-1976.

Selection:



A DECISION WE'RE GUARANTEED TO REGRET

Recently several amazing survival stories appeared in the news. One featured the story of Georgie Knox from Alberta, Canada who struck a coyote with her car at highway speed. She heard a “crunch” sound and assumed she had killed the critter. Then, 21 miles later, someone motioned to her that there was something stuck to the grill of her car. She stopped to find - the coyote implanted in the grill, badly shaken but alive and well. Fish and Wildlife personnel inspected the coyote for injuries, then released him back into the wild.

But a far more obscure, but important story received almost no attention from the media. A 24-year-old woman in the Wuhan prefecture of China, attempted suicide by leaping from a bridge spanning the Yangtze River. The woman, identified only by her surname Li, had been publically shamed by her employer. She was so distressed that she thought death was her only escape. But she didn't die – even though the waters were bone-chilling and river swept her downstream for 25 miles – a journey that lasted five hours! Finally, police plucked her from the frigid waters alive and well.

What struck me about this woman was her comment to the police and media. She told them that, the instant she jumped from the bridge, she immediately regretted her decision. This is why she fought so hard to save her life while in the grip of the turbulent waters.

That very same comment about immediate regret has been voiced by almost all survivors of suicide attempts. Of the 1600-1800 people who have jumped from the Golden Gate Bridge, only 2% have survived the fall. And every one of them has made the same comment – the moment they lunged from the bridge they immediately regretted their decision. Suddenly their eyes were opened and they realized how precious life was to them.

A recent ABC article highlighted this same fact when it featured the story of two such survivors of suicide attempts. The survivors were Kevin Hines and Ken Baldwin. Kevin Hines told an ABC reporter, “The millisecond my legs cleared it, the millisecond of true free fall, (I felt) instant regret for my actions.” Ken Baldwin agreed. “I just vaulted over (the rail), and I realized, at that moment, this is the stupidest thing I could have done.”

Both men also expressed profound gratitude that they have lived to experience unforeseen joys - that they would have otherwise missed had their lives ended. Kevin Hines met the love of his life and married – his father serving as his best man. Ken Baldwin lived to give away his daughter in marriage and to see his first grandchild. Their deep depression at the time they attempted suicide blinded them to all the joys that lay ahead.

Friend, if you are depressed and feeling worthless, helpless, and hopeless – then I assure you that your vision is impaired. You're not seeing things as they are. Your life is truly wonderful and God loves you more than you could ever imagine. And He's got so many wonderful chapters of your life left to live. Yes, there is one decision that we will always regret - the decision to throw away God's greatest gift.

PRAYER: Dear Father in heaven, open my eyes to see all the blessings You have poured into my life and to see the possibilities of good things yet to come. Give me, O God, the will to live and fulfill Your purpose for my life. Amen.


